# 7.0 Joint Info Awareness Morning.

St. Luke's PPG are interested in joining together with Pinfold Medical in a Joint Information Awareness Update Morning. It would be preferable if all practices to be involved. A Carers Health Awareness program in the summer could be a good way to promote joint working of the practice PPG's

## 8.0 Car Park Modifications.

It is proposed that the current dangerous bottleneck at the entry to the carpark be removed by having an exit in Woodhall Street. This will mean the loss of a couple of car parking spaces but is necessary to avoid the current unsatisfactory traffic flow. A user group meeting with NHS Property Services and the practice managers would be a useful way to discuss this.

Cleaners should be encouraged to communicate maintenance problems such as broken toilet door locks and other issues to Practice Managers

## 9.0 Pinfold Medical News.

Rhasda has asked the PPG to provide feedback on how the merger of Field Road and All Saints Surgeries has worked and a survey will be been sent out to the PPG for their views to be recorded. The CQC has visited the Pinfold Medical Practice and has highlighted two areas where improvement is required. The inspection found that improvement was necessary in the effectiveness of the practice in providing services to people with long term conditions and in the provision of well led services in the development of an effective quality improvement programme.

The full report can be found on the CQC website. A follow up inspection is expected. The scores for how patients described their experience of using the Practice and the experience of making an appointment have both dropped and are below the National Average.

## 10.0 Patient Welcome Screen and Signage.

With the Field Road and All Saints parts of the practice being physically separated but doctors being shared between both there is the potential for confusion especially concerning where to wait for an appointment. In addition, the Notification screen used to inform patients that the doctor is ready to see them is not easily viewed from the whole of the waiting area.

It was suggested that the Welcome Screen should make people aware that they should monitor the Notification screen whilst waiting.

It should be noted that most appointments now take place on the All Saints side of the building
